



The World Is Being Held Hostage!

We now have the statistics that prove coronavirus is no different than the seasonal flu. Back at the beginning of the year, extreme life-debilitating measures were instituted and followed by a public believing experts who were attempting to explain a virus they knew nothing about. Today the facts are in: lockdowns, mask-wearing, and toxic pollution from disinfectants need to end immediately as these measures are causing more harm and damage to humanity world-wide than coronavirus ever possibly could.

The scientists and doctors who are stepping up with the truths are to be applauded.

Dr. Ioannidis is the C.F. Rehnborg Chair in Disease Prevention at Stanford and is a Professor of Medicine, of Epidemiology and Population Health and of Biomedical Data Science there. The warnings from Dr. Ioannidis' **March 17,**

2020 article on COVID-19 have been confirmed. At that time, due to insufficient data, he said:

“The current coronavirus disease, COVID-19, has been called a once-in-a-century pandemic, but it may also be a once-in-a-century evidence fiasco. At a time when everyone needs better information, from disease modelers and governments to people quarantined or just social distancing, we lack reliable evidence on how many people have been infected with SARS-CoV-2 or who continue to become infected. Better information is needed to guide decisions and actions of monumental significance and to monitor their impact.”¹

In a **June 2, 2020** interview with *Greek Reporter USA*, Dr. Ioannidis stated:

“I feel extremely sad that my predictions were verified. Major consequences on the economy, society and mental health have already occurred. I hope they are reversible, and this depends to a large extent on whether we can avoid prolonging the draconian lockdowns and manage to deal with COVID-19 in a smart, precision-risk targeted approach, rather than blindly shutting down everything.”²

On **July 23, 2020** Dr. Ioannidis stated:

“The unreliability of COVID-19 data is a problem everyone seems to agree on.”

These words are from an Internet article titled: John Ioannidis Warned COVID-19 Could Be a “Once-In-A-Century” Data Fiasco. He Was Right.”³

He is not the only doctor issuing these cautions, other researchers are also sounding the alarm. Experts warn in an article on coronavirus in *Expert Review of Molecular Diagnostics*:

“In conclusion, according to the mentioned reasons, the results of real-time RT-PCR tests must be cautiously interpreted.”⁴

Indeed, caution is called for. An article in the **September 2020** *British Medical Journal* described some of the troubles that arise from only using PCR testing to monitor coronavirus: “COVID-19: The Problems with Case Counting.”⁵

In it, Carl Heneghan, director of the Centre for Evidence Based Medicine at the University of Oxford and the editor of *BMJ Evidence-Based Medicine* states:

*“We are moving into a biotech world where the norms of clinical reasoning are going out of the window. A PCR test does not equal COVID-19; it should not, but in some definitions it does.”*⁵

The extreme sensitivity of the PCR test is a problem.

In the same **September 2020** *British Medical Journal* article, it also stated:

*“Another problem with relying on PCR testing alone to define a COVID-19 case is that, owing to the sensitivity of the test, it can pick up a single strand of viral RNA—but this doesn’t necessarily equate to someone being infected or infectious.” . . . “Many of these people might have had an active infection some weeks ago and are still carrying the RNA in their nasal swabs: it might not actually be live virus that you are picking up.”*⁵

Not Our Regular Newsletter Format

This is a very different format for our Newsletter. We are including links below to the important video and transcript by an International consortium of lawyers who have been gathering data to file a lawsuit against the World Health Organization for Crimes Against Humanity. 

Mask Theory

Bob's Note: The following was forwarded to us by a hospital worker who gives us his/her take on the "Mask Theory." Please review this and we welcome your comments and would love to hear how you feel about this.



From a hospital worker:

For all you mask wearers (especially those of you who think wearing it outside is NOT stupid ☐☐♀). I know I'm about to burst your "google doctor degree" bubble, but here goes nothing.

So Masks?

I am OSHA certified. I know some of you are too. I don't really know WHY OSHA hasn't come forward and stopped the nonsense BUT I want to cover 3 things:

- N95 masks and masks with exhale ports
- surgical masks
- filter or cloth masks

Okay, so upon further inspection, OSHA says some masks are okay and not okay in certain situations.

If you're working with fumes and aerosol chemicals and you give your employees the wrong masks and they get sick, you can be sued.

- **N95 masks:** are designed for CONTAMINATED environments. That means when you exhale through N95 the design is that you are exhaling into contamination. The exhale from N95 masks are vented to breath straight out without filtration. They don't filter the air on the way out. They don't need to.

Conclusion: if you're in Target and the guy with Covid has a N95 mask, his covid breath is unfiltered being exhaled into Target (because it was designed for already contaminated environments, it's not filtering your air on the way out).

- **Surgical Mask:** these masks were designed and approved for STERILE environments. The amount of particles and contaminants in the outside and indoor environments where people are CLOGGING these masks very, VERY quickly. The moisture from your breath combined with the clogged mask will render it "useless" IF you come in contact with Covid and your mask traps it, YOU become a walking virus dispenser. Every time you put your mask on you are breathing the germs from EVERYWHERE you went. They should be changed or thrown out every "20-30 minutes in a non-sterile environment."

- **Cloth masks:** I can't even believe I'm having to explain this, but here it goes. Today, three people pointed to their masks as they walked by me entering Lowe's. - * The surgical mask is not designed for the outside world and will not filter the virus upon inhaling through it. - * Cloth masks are WORSE than none. It's equivalent to using a chain link fence to stop mosquitos.

These forces deny American families critical information about treatment efficacies and funding to cover naturopathic costs. No major insurance carriers specializing in cancer/heart/stroke/critical illness policies are to be found that pay benefits for specific natural protocols.

However, both the cures for cancer as well as finances for natural treatments are within your reach.

Many Americans today hold life insurance policies. 



Sigmoid Colon/Liver Cancer Testimonial

“First diagnosed with sigmoid colon cancer on 04/09/2017 with 5cm tumour. I went surgery after a few weeks time but surgeon was unable to remove tumour because it has penetrated into the bladder.




